

MediaValet License Agreement:

Tourism Nova Scotia's digital assets library contains images and footage of Nova Scotia in high-resolution formats and are made available to tourism industry and operators, including travel writers, media representatives, and other travel trade representatives for use in promotion of Nova Scotia as a tourism destination. **Assets may only be used to promote the specified location and/or business as noted in the metadata.** By downloading content from the digital assets library, you accept the terms of this agreement.

These digital assets are available at no cost and may be reproduced for the following purposes:

- promotional materials, not intended for retail sales, such as brochures promoting a specific area and/or all of Nova Scotia
- convention and trade show materials, not intended for retail
- articles for newspaper, magazines and broadcast featuring the province of Nova Scotia
- web sites promoting Nova Scotia and/or to create awareness
- social media promoting travel to Nova Scotia

Digital assets cannot be used for commercial purposes. For example, the following types of uses are prohibited:

- materials related to tobacco, alcohol and religious or moral issues
- retail items or materials intended for sale such as books, calendars, postcards, place-mats, screen savers, or souvenirs (e.g., T-shirts, playing cards, water bottles, etc.)
- packaging or promotion of products intended for sale
- personal and commercial letterhead and promotional materials
- materials designed for interior decoration
- materials used for partisan political purposes
- advertising materials to promote non-tourism related business
- use or incorporation of the digital asset into a trademark or logo
- promotion of real estate businesses or properties for sale, unless explicitly working in partnership with Tourism Nova Scotia

The digital assets are the property of Tourism Nova Scotia or other contributors with all rights reserved except those expressly given under this agreement.

The digital assets are protected by Canadian copyright law, trade-mark law and international treaties.

This is a non-exclusive, non-sub licensable and non-transferable license given by Tourism Nova Scotia to you as the user for a one-time use for the digital assets you have selected and will include in the order form, and accompanying written material for a single use consistent with this agreement.

You may not alter the digital assets electronically or otherwise or create derivative works. The use of any Artificial Intelligence systems, solutions or tools ("AI Systems") on the digital assets to

alter, copy or modify or creative derivative works is expressly prohibited. You may not scrap or otherwise translate or convert the digital assets through the use of any AI System. For greater clarity, AI System means a technological system that, autonomously or partly autonomously, processes data related to human activities through the use of a genetic algorithm, a neural network, machine learning or another technique in order to generate content or make decisions, recommendations or predictions.

Cropping, sizing and creating montages are allowed.

You are authorized to make one copy of the digital asset for back-up or archival purposes only if you reproduce all copyright and other proprietary notices that accompany the digital asset.

Anytime a digital asset appears in print or broadcast, credit must be given to Tourism Nova Scotia and/or the photographer (as outlined with each image).

You may not rent, lease, sublicense or otherwise assign or transfer your interest in the digital assets.

Digital assets reproduced on the Internet may only be used at 72 dpi or lower.

Copying the digital assets and the material in whole or in part, except according to the terms and conditions of this license, is forbidden without prior written permission from Tourism Nova Scotia.

Tourism Nova Scotia's Digital Assets Library materials cannot comprise more than 50% of the image content of any commercial guide book, CD, DVD or video.

You agree to indemnify and hold harmless Tourism Nova Scotia, its officers, employees and agents from and against all claims, demands, losses, costs, damages, actions, suits or other proceedings of any kind arising out of your use of the digital assets.

Limitation of Liability

Under no circumstances, including, but not limited to, negligence shall Tourism Nova Scotia be liable for any direct, indirect, special, punitive, incidental, or consequential damages arising out of the use of, or the inability to use, the website and/or the digital assets.

Termination

Tourism Nova Scotia may terminate this agreement, including any licenses contained herein, at any time and further may terminate the user's access to any and all portions of the digital assets library if Tourism Nova Scotia determines, in its sole discretion, that the user failed to comply with any term of this agreement. Upon termination, the user must cease use of the digital assets library and destroy all materials obtained from this library, and all related documentation and all copies thereof, whether made under this agreement or otherwise, and/or take any additional or alternative reasonable steps that Tourism Nova Scotia may direct in respect of the termination of the use.
